**I. INTRODUCTION TO THE 2017 PLAN UPDATE**

**A. OVERVIEW OF PLANNING PROCESS**

<sup>1</sup> *The figures in this Comprehensive Plan include parcels which have been the subject of annexation proceedings by the Village of Kiryas Joel and such annexation was the subject of legal challenges that remain pending in the Appellate Division. Upon a final determination of the legal proceedings, the 164 acres will either be outside the Town and part of the Village, or shall remain in the Town of Monroe in which case the Comprehensive Plan Update applies to same. Further, certain parcels of land located in the Town of Monroe are the subject of a petition and permissive referendum to be held on November 7, 2017, to incorporate same into a newly created Town of Palm Tree. At the time of adoption of this Comprehensive Plan Update, the Town of Palm Tree has not yet been formed, and those parcels are still subject to this Comprehensive Plan Update.*
