- 4. Check the Type of License you are applying for, and be sure to include proof of age if applying for the Senior Citizen discount. Submit appropriate payment by cash, check or money order made payable to, Town of Monroe.
- 5. For validation of this license, submit in person or by mail the application, fee, veterinarian's certification of spaying or neutering or proof of exemption, and proof or rabies vaccination to the Monroe Town Clerk's office.
- 6. You should receive your next year's license renewal by mail from the Town Clerk's office 30 days prior to the expiration date of this license. If a renewal is not received, contact Valerie Bitzer, Town Clerk at (845) 783-1900 ext. 203.

NOTE: For replacement of a lost Identification Tag, call or visit the Town Clerk's Office to request a new one. There is a \$3.00 fee for a replacement ID tag.
