APPLICATION FOR BUILDING PERMIT

INSTRUCTIONS:

- a. This application must be completely filled out and submitted in duplicate to the Building Inspector.
- b. **This application must be accompanied by two survey's drawn to scale** locating clearly and distinctly all buildings and wetland (lakes, ponds, streams, swamps, marsh, etc), whether existing or proposed, and indicate all set-back dimensions from property lines. Give lot and block numbers or description according to deed, and show street names and indicate whether interior or corner lot.
- c. **This application must be accompanied by two sets of plans and specifications drawn to scale showing proposed construction.** Plans and specifications shall describe the nature of the work to be preformed, the materials and equipment to be used and installed and details of structural, mechanical, electrical and plumbing installations. If a Zoning Board of Appeals variance was issued, submit a copy with this application.
- d. Upon approval of this application, the Building Department will issue a Building Permit to the applicant together with approved duplicate set of plans and specifications. Such permit and approved plans and specifications shall be kept on the premises available for inspection by the Building Department.
- e. **Workman's Compensation and Liability Insurance to be submitted with application.**

APPLICATION IS HERBY MADE for the issuance of a Building Permit, the applicant agrees to comply with all applicable laws, ordinance and regulations.
