

ADVERTISEMENT FOR BIDS

Receipt of Bids: Sealed Bids on forms prepared by the Engineer will be received by the Town of Monroe until 2:00 PM (local time) on 20 March 2020, for the **Automation of Senior Center Doors Contract 1G-General Construction** in accordance with the Drawings, Specifications, and other Contract Documents prepared by McGoey, Hauser and Edsall Consulting Engineers, D.P.C., 33 Airport Center Drive, Suite 202, New Windsor, New York 12553.

Bids will be publicly opened and read at 2:00 PM (local time) on 20 March 2020 at the offices of the Town of Monroe Town Clerk's office 1465 Orange Turnpike, Monroe, New York 10950. **The Information for Bidders, Drawings, Specifications and other Contract Documents may be reviewed at the offices of McGoey, Hauser and Edsall Consulting Engineers, D.P.C., 33 Airport Center Drive, Suite 202, New Windsor, New York and obtained from the Town of Monroe Town Clerk's office 1465 Orange Turnpike, Monroe, New York 10950 becoming available on 2 March 2020 upon payment of a deposit of \$50.00 for electronic (PDF) format and provided in digital media upon payment with a check made payable to the "Town of Monroe" in the (non-refundable) amount. Contract Documents are also available in "hard copy" upon payment of a deposit of \$50.00 upon payment with a check made payable to the "Town of Monroe".** Addenda, if any, will be issued to only those persons whose name and address are on record of having obtained the Contract Documents.

Contract Documents are available by mail, upon written request to the Engineer, and pre-payment, of an additional (non-refundable) charge of \$45.00 per set (\$15.00 handling and \$30.00 mail), payable to McGoey, Hauser and Edsall Consulting Engineers, D.P.C. Documents will be forwarded via Federal Express.

The deposit for hard copy set will be refunded upon return of the Contract Documents to the Owner in unmarked and good condition not later than fifteen (15) days following the opening of Bids.

Each bid shall be accompanied by an acceptable form of Bid Guarantee in an amount equal to at least five (5) percent of the amount of the Bid payable to the Town of Monroe as a guarantee that if the Bid is accepted, the Bidder will, within fifteen (15) days after the award of the Contract, execute the Contract and file acceptable Performance and Labor and Material Payment Bonds and Certificate(s) of Insurance.

OWNERS RIGHTS RESERVED: The Town of Monroe, hereinafter called the Owner, reserves the right to reject any or all Bids and to waive any informality or technicality in any Bid in the interest of the Owner.

STATEMENT OF NON-COLLUSION: Bidders on Contracts are required to execute a non-collusive bidding affidavit pursuant to Section 103d of the General Municipal Law of the State of New York.

Attention of bidders is particularly called to the requirement as to conditions of employment to be observed and the minimum wage rates to be paid under the Contract, Section 3, Segregated Facilities, Section 109, and Executive Order 11246.

Bidders are also required to comply with the provisions of Section 291-299 of the Executive Law of the State of New York.

Prevailing wages established under the Davis-Bacon Act will apply to this contract. The contract documents contain requirements addressing prevailing labor wage rates, labor standards, nondiscrimination in hiring practices, goals for minority and female participation, MWBE participation, and, for projects over \$100,000, participation by Section 3 residents and businesses, related matters. Provisions under 2 CFR Part 200 will apply to the awarded contract.

The Bidders/offerors must submit documentary evidence of minority and women business enterprises who have been contracted and to whom commitments shall be submitted concurrently with the bid.

No bidder may withdraw his bid within forty-five (45) days after the actual date of the opening thereof.

Subject to the provisions of Article 28, Part III of the New York State Tax Law and the provisions of the Contract Documents, the Owner is exempt from payment of sales and compensating use taxes of the State of New York and cities and counties on all materials supplied to the Owner pursuant to this contract.

The Town of Monroe hereby notifies all bidders that it will affirmatively insure that in regard to any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the ground of race, gender, color or national origin in consideration of an award.
